TERMS AND CONDITIONS

- 1. This application is a request by the Applicant(s) for booking of apartment / plot after being aware of the location and Project. Laasya Projects reserves the right to refuse or accept this application. Completed application will be processed by Laasya Projects only after encashment of the Cheque provided for booking. If the application is in joint names, both the applicants need to sign the application form.
- 2. All payments for the Plot/Flat booked will be by cheque/demand draft drawn in favour of Laasya Projects.
- 3. The applicant(s) agree to execute the Agreement for sale in standard format within stipulated period of 90 days from the date of this Application Form.
- 4. No transfer /resale of the apartment / plot will be allowed prior to payment of 100 % of the total sale price. Transfer fee of Rs.100/- per sft for transfer /resale shall be payable to Laasya Projects Pvt Ltd by the Transferor.
- 5. The applicant(s) agree that the cancellation of booking by them will be only in exceptional cases. Laasya Projects, based on merits of the case will have the sole discretion to consider / approve the cancellation.
- 6. The applicant(s) state that in case they decide to cancel the booking / agreement and if the same is considered / approved by Laasya Projects, then Laasya Projects are entitled to retain 25% of the total amount paid and the interest accrued on total payment.
